 Provide Revision for Fire Alarm System Approval Prior to rough inspections, if Fire Alarm System is required.
 All Tenant Walls must be complete Fire Walls and inspected as such.

1. A development permit is required to add or replace outdoor lights in the Gulf Beach, Gulf Beach Ridge, or Bay Beach zones. Must submit the "Sea Turtle Lighting Plan" worksheet as a permit revision prior to installation.
2. Tinted glass shall be installed on all windows and glass doors within line of sight of the beach. Tinted glass means any glass treated to achieve an industry-approved, inside-to-outside light transmittance value of 45 percent or less. Such transmittance is limited to the visible spectrum (400 to 700 nanometers) and is measured as the percentage of light that is transmitted through the glass (COG; center of glass). Must submit "Window-Door-Shutter" worksheet as a permit revision prior to installation.

This permit has been issued on condition that if the owner decides to perform additional permitted work to the structure other than this permits scope of work or to modify the work described, that the City of Sanibel will review the comparison of the cost of this permit and any additional permit costs to the market value of the building to determine if the work is substantial improvement in compliance with the 50% rule. All work shall be in compliance with the 2020 Florida Building Codes 7th Edition. All construction debris must be legally removed from site and disposed of in compliance with all Federal, State, and Local rules and regulations.
