The enclosed Candidate Information Sheet may be used for this purpose. All information sheets must be furnished to the Association on or before **October 4, 2025**.

The information sheets and a voting ballot will be mailed to the members along with the Second Notice of Annual Meeting at least fourteen (14) days before the annual meeting.

as their representative to cast all votes and to express all approvals that such owners may be entitled to cast or express at all meetings of the membership of the Association, and for all other purposes provided by the Declaration, the Articles of Incorporation, and the Bylaws of the Association.

NOTE - This Certificate is not a proxy form. Pursuant to § 718.103(33), F.S., this Certificate serves to designate one of the record title owners, or the corporate, partnership, or entity representative, who is authorized to vote on behalf of a Unit that is owned by more than one owner or by any entity. This Certificate permanently specifies who, amongst the owners of a Unit or the representative of an entity that owns a Unit, may cast a vote on behalf of the Unit or complete a proxy form for a specific meeting. The following examples illustrate the proper use of this Certificate:

- (1) Unit owned by John Doe and his brother, Jim Doe. Voting Certificate can designate either John or Jim as the voting representative (not a third person).
- (2) Unit owned by Overseas, Inc., a corporation. Voting Certificate can be filed designating an officer or employee entitled to vote, signed by the President or Vice-President of the corporation and attested to by the Secretary or Assistant Secretary of the corporation.
- (3) Unit owned by Bill and Mary Rose, husband and wife. Voting Certificate can designate either Bill or Mary as the voting representative (not a third person).

This Certificate is made pursuant to the Condominium Documents of Sanibel Moorings Condominium Association, Inc. This Certificate hereby revokes all prior Certificates. This Certificate shall be valid and in effect until this Certificate is revoked by a subsequent Certificate or until ownership of the affected Unit changes.
